- (iv) You use credit reference agencies and fraud prevention agencies to:-

 - if I give you false or inaccurate information or you suspect fraud.
- Credit reference agencies keep a record of your enquiries and may record, use and give out information you give them to other lenders, insurers and other organisations. This also applies to fraud prevention agencies if I give you false or inaccurate information or you suspect fraud. The information may be used to make assessments for credit and to help make decisions on me and members of my household, on credit, motor, household, life, and other insurance facilities (including handling claims), for debt tracing and to prevent fraud and money laundering, information held about me by the credit reference agencies may already be linked to records relating to one or more of my partners where a financial "association" has been created. Any enquiry you make at a credit reference agency may be assessed with reference to any "associated" records.
- (v) You may give information about me and how I manage my account to the following:
 - People who provide a service to you or are acting as your agents, on the understanding that they will keep the information confidential.
 - Anyone to whom you transfer or may transfer your rights and duties under this agreement.
 - You may also give out information about me if you have a duty to do so or if the law allows you to do so. Otherwise you will keep information about me confidential.
 - To any company where I act as guarantor of a Barclays Marine loan taken out by that company
